FALL 2024 REGISTRATION:

Fall 2024 Registration	
Classes	When to Register
Session 1 and 3-credit classes	April 22 to August 8
Late Registration (Session 1 and 3-credit classes)	August 9 to August 15
Session 2 classes	September 3 to October 7

Registration for Fall Semester 2024 Session 1, 2-credit and 3-credit classes will take place April 22 to August 8. That may sound like a long time, but we encourage you to register early and buy your textbooks to avoid late fees and not having your textbooks by the time classes start. Late registration closes on August 15 and Fall Semester classes begin on August 20. Session 2 registration opens on September 3.

Register early! And remember to purchase your textbooks so you'll have them when classes start on August 20.

Deferring Courses Policy	
Week of Class	Options
During Week 1	Drop classes <i>No financial/transcript penalties</i>
Weeks 2-4	Defer classes <i>\$50 deferral fee, no transcript penalty</i>
Weeks 5-8/17	Two Options: 1) Incomplete – <i>Can petition under certain circumstances</i> 2) Withdrawal – <i>Forfeit tuition/fees, permanent "W" on transcript</i>

As a reminder, you can DROP a class without penalty during Week 1 of the class. After the first week, there are financial and/or transcript penalties for deferring or withdrawing from a class. Should you need to leave a class part way through the semester, your options depend on how far into the class you are.

During Weeks 2-4, you can DEFER your class, meaning that you will be charged a \$50 deferral fee, but your tuition and fees for the class will be credited to your account and you will not see the class appear on your transcript for that semester.

If you wait until Week 5 to leave a class, you can petition for an INCOMPLETE or WITHDRAW from the class. In order to petition for an Incomplete, a student must have completed at least 75 percent of their work for the class and demonstrate a hardship that prevents the completion of the class on time.

Instructors will review petitions on a case-by-case basis. If granted, the student receives a new date to complete the remaining portion of his or her class work.

If you are not eligible for an Incomplete, or your petition is denied, you can Withdraw from the class, receive a “W” on your transcript and re-take the class in a future semester, forfeiting your tuition and fees for the class.

Week of Class	Session 1, 2- and 3-credit classes	Session 2 classes
Week 1: <i>Drop Period</i>	Aug. 20-26	Oct. 22-28
Weeks 2-4: <i>Deferral Period</i>	Aug. 27-Sept. 17	Oct. 29-Nov. 18
Weeks 5-8/17: <i>I/W Period</i>	Begins Sept. 18	Begins Nov. 19

This chart shows these important dates for Fall Semester 2024. As you can see, **the dates for each period depend on when the class begins.** It is important to be mindful of these dates as you begin your courses. **Should you need to drop, defer or withdraw a course, contact the Registrar immediately for assistance** so that you don’t miss an important timeline.

In PSYC 1201 you will learn the ascended masters' teachings on the psychology of the soul interwoven with the foundational principles of the psychology of psychosynthesis developed by Roberto Assagioli, an Italian psychiatrist. PSYC 1201 is available to all students as a general studies course and is also a required course for the leadership and ministerial studies curriculum.

Other general studies courses being offered this Fall Semester include RELS 1005 Survey of the World Religions and MINS 2770 The Holy Spirit: Fire from Heaven. These two courses are also required courses for the Level Two ministerial studies curriculum.
